 Reorganisation and Dorset Local Plan: The clerk is to prepare a response to the
 Local Government Reorganisation survey and circulate to councillors prior to
 responding. Local residents are to be reminded to take part in the Local Plan
 consultation including the renewable energy plans.
- 25/100. National Pay Award: The clerk's salary will be increased in line with the award.
- **25/101. Voluntary Registration of Village Hall Deeds:** The deeds to the Village Hall are currently unregistered and this can cause issues re storage etc. The clerk has investigated legal costs and these are around £1200 +VAT in addition to the HMLR fees. - **25/102. The Lodge Rent Review:** The Letting Agents advised that the rent review is due and, following discussion, the Council voted to increase the rent by 2.94% to £875pcm. Proposed Cllr Cheesley, seconded Cllr Woodford.
