25/120. Ward Councillor Report: Cllr Cooper reported that detailed discussions are taking place on the finer details of the Housing/ Local Plan.

25/121. Open Forum: Council staff have marked the road by the dropped kerb on the A350 at the School.

Cllr Cooper is to chase Highways regarding the broken 40mph sign to the South of the village and the pathway by the School.

Cllr Cheesley raised the issue regarding the green safety fencing at the field by the Church which is rotting and causing an obstruction.

Part of the new flooring in the hall is raised and needs the contractor to return and correct this.

Items for Decision:

25/123. Devolving Dorset – review of DAPTC seminar: The clerk attended this meeting and gave a brief outline of discussions.
