26/14. Open Forum: James Statham, Project Lead, Dorset Council (Bridges & Highways Structures) gave an update on the position regarding the closed Bridleway and bridge at Keyneston Mill. Applications have, or are being, submitted to the Environment Agency, Dorset Council Conservation Officers and the Mill owner for permission to commence the work. He is hopeful that this can be started in July and completed before the river levels start to rise again. There is no intention to close the Bridleway permanently.

Mr Moss raised the issues regarding the fencing by the Church. Clerk to contact the landowner and ask for resolution. The pavement alongside the wall at the School/Church is uneven and dangerous. Clerk to contact Highways.

Cllr Hall raised the issue regarding the broken 40mph sign. Cllr Cooper to progress. The flooding and broken road surface at the top of West End is causing major concerns to residents. Clerk to contact Highways.

Cllr Woodford asked if we could express our thanks to Mr Harry Dipple for replacing the mailbox outside the Village Hall.
